Meeting Called to Order

Verified quorum and surveyed board members for additional discussion points to be added. Amy welcomed the homeowners who joined us on line, and explained the Zoom protocols.

We reviewed last months' meeting minutes and approved them.

Community Association Partners (Kim Adolf)

All CAP business was conducted over the phone, in accordance with CAP's Corona Virus protocol, and on line via Zoom.

Kim presented the September financial report. The financial report was approved by the Board.

Collections: 22 unpaid 2020 accounts sent to collection. One homeowner requested a reduction in the late/attorney fees incurred and that was not approved.

Community Fun Committee Update: No committee business done.

Late Fee Resolution: Kim presented a general resolution, from our attorney, to address the late fees incurred by homeowners. It was approved by the Board.

A homeowner requested that a tree, near his property, be trimmed or removed because of potential future damage to his property. CAP will have our arborist inspect the tree and advise the Board of the best option, moving forward.

RV Paring: The Board discussed the definition of an RV and moved forward with requesting homeowners to remove illegally parked RV's. CAP will contact homeowners to see if they consider their vehicle an RV.

Draft Budget 2021: CAP presented the proposed budget and the Board voted to approve it.

Annual Meeting Date: The Board voted to set the date for the Annual Meeting as January 21, 2021 @ 7PM. It may have to be held via Zoom, depending on the pandemic situation.

Open Board Position: One homeowner submitted an application to fill the vacant Board position. The Board voted to add Gian Paulo Mammone to that positions.
