Special Meeting Business Items

<u>Board Director Positions</u> - The current board is Josh Smith, Kathy Pattison, Tina Taplin, Reg Carey, and Lonny Henry (not in attendance). The board will formally vote to appoint new members for the current four vacant positions.

Open Position for 2022 - 2025 - Tina nominates Mia Admire, Reg seconds the nomination. The vote is unanimous for Mia Admire.

Open Position for 2021 - 2024 - Mia nominates Andra Fletcher, Kathy seconds the nomination. The vote is unanimous for Andra Fletcher

Open Position for 2021 - 2024 - Mia nominates Matthew Burg, Tina seconds the nomination. The vote is unanimous for Matthew Burg.

Open Position for 2020 - 2023 - Tina nominates Laurie Farley, Kathy seconds the nomination. The vote is 4 votes in favor and 4 abstaining.

<u>Board Officer Positions</u> - Mia nominates Andra for Secretary, Tina seconds the nomination. The vote is unanimous for Andra as Secretary.

Kathy nominates Reg for Vice President, Tina seconds the nomination. The vote is unanimous for Reg as Vice President.

The position of Treasurer is currently unfilled for now.

<u>Board Meeting Schedule</u> - In the past the board shifted to holding meetings every other month. With the current workload monthly meetings are needed again.
